We trust the beginning of the New Year has started well for you. We have a lot of information that may be helpful for you as you head into these winter months. We wanted to get this into your hands as soon as possible.

1. **PACAPE is actively working to make sure the Federal Tax Credit is adopted in PA.** We hosted a meeting of PA coalition team members to strategize ways to encourage the Governor to opt into the credit as soon as possible. We are encouraged by some things we are seeing, but our whole private school community must work together to help message this in a positive way! 2. **Safety Grant Announcement #1:** PCCD has released a SEPARATE safety grant for non-profits that you might be interested in looking at: The grant is now open and is due on January 12<sup>th</sup>.
